A RESOLUTION

Approving and accepting a grant in the amount of \$468,367 from the United States Centers for Disease Control and Prevention (CDC), to fund the FSM Public Health and Hospital Emergency Preparedness Project, including all the terms and conditions of the assistance.

1 WHEREAS, on June 25, 2020, the United States CDC issued a
2 Grant Award to the FSM Department of Health and Social Affairs for
3 the purpose of funding the FSM Public Health and Hospital
4 Emergency Preparedness Project; and

5 WHEREAS, this grant will be very useful to support the needs
6 of the Nation given the ongoing COVID-19 pandemic; and

7 WHEREAS, section 210(2) of title 55 of the Code of the
8 Federated States of Micronesia (Annotated), as amended, provides
9 that for foreign financial assistance to be valid it must be
10 approved by Congress by resolution; now, therefore,

11 BE IT RESOLVED by the Twenty-First Congress of the Federated
12 States of Micronesia, Sixth Special Session, 2020, that Congress
13 hereby approves and accepts the grant in the amount of \$468,367
14 from the United States CDC, to fund the FSM Public Health and
15 Hospital Emergency Preparedness Project, including all the terms
