A RESOLUTION

To approve and accept a \$125,000 grant from the U.S. Department of Health and Human Services, Centers for Disease Control and Prevention, (U.S. CDC), to fund the Behavioral Risk Factor Surveillance System (BRFSS) Monitoring and Surveillance Project in the FSM, including all the terms and conditions of the assistance.

1 WHEREAS, the U.S. CDC issued a grant award on July 28, 2020,
2 to the Government of the Federated States of Micronesia providing
3 support to fund the Behavioral Risk Factor Surveillance System
4 (BRFSS) Monitoring and Surveillance Project in the FSM; and

5 WHEREAS, section 210(2) of title 55 of the Code of the
6 Federated States of Micronesia (Annotated) provides that for
7 foreign financial assistance to be valid it must be approved by
8 Congress by resolution; now, therefore,

9 BE IT RESOLVED by the Twenty-First Congress of the Federated
10 States of Micronesia, Seventh Special Session, 2020, that Congress
11 hereby approves and accepts the \$125,000 grant from U.S. CDC to
12 fund the BRFSS Monitoring and Surveillance Project, including all
13 the terms and conditions thereof; and




