A RESOLUTION

1           WHEREAS, during the Fourth Regular Session of the Twenty-  
2 First Congress the President submitted the nomination of Mrs.  
3 Shanty Sigrah Asher to serve as the FSM Consul General in  
4 Honolulu, Hawaii; and

5           WHEREAS, the resolution approving the nomination has been  
6 rejected, and its reconsideration has also failed, and under 2  
7 F.S.M.C. §207(3) the nomination may not be resubmitted by the  
8 President during the Twenty-First Congress without  
9 authorization by Congress; now, therefore,

10           BE IT RESOLVED by the Twenty-First Congress of the  
11 Federated States of Micronesia, Fifth Regular Session, 2020,  
12 that Congress hereby authorizes the President to resubmit the  
13 nomination of Mrs. Shanty Sigrah Asher to serve as the FSM  
14 Consul General in Honolulu, Hawaii; and


