A RESOLUTION

Approving and accepting a grant from the U.S. Federal Aviation Administration (FAA) in the amount of \$1,111,111, to provide funding for the project entitled: "Acquire Aircraft Rescue and Firefighting Vehicle", for the Kosrae International Airport, including all the terms and conditions of the assistance.

1           WHEREAS, on August 6, 2020, the U.S. FAA approved a federal  
2 funding application for the project entitled: "Acquire Aircraft  
3 Rescue and Firefighting Vehicle", for the Kosrae International  
4 Airport in the amount of \$1,111,111; and

5           WHEREAS, the Government of the Federated States of Micronesia  
6 wishes to express its appreciation to the Government of the United  
7 States and the U.S. FAA for this generous grant; and

8           WHEREAS, this is a foreign financial assistance as defined  
9 under section 210(1)(b) of title 55 of the Code of the Federated  
10 States of Micronesia (Annotated), as amended;

11           WHEREAS, section 210(2) title 55 of the Code of the Federated  
12 States of Micronesia (Annotated), as amended, requires that for  
13 foreign financial assistance to be valid it must be approved by  
14 Congress by resolution; now, therefore,

15           BE IT RESOLVED by the Twenty-First Congress of the Federated  
16 States of Micronesia, Fifth Regular Session, 2020, that Congress  
17 hereby approves and accepts the \$1,111,111 grant from the U.S. FAA  
18 to fund the project entitled: "Acquire Aircraft Rescue and  
19 Firefighting Vehicle", for the Kosrae International Airport,  
20 including all the terms and conditions thereof; and

1 BE IT FURTHER RESOLVED that certified copies of this  
2 resolution be transmitted to the President of the Federated States  
3 of Micronesia, the Secretary of the Department of Transportation,  
4 Communications and Infrastructure, the Secretary of the Department  
5 of Finance and Administration, the Secretary of the Department of  
6 Justice, and the U.S. Embassy in Kolonia.


