A RESOLUTION

Approving and accepting a grant in the amount of \$1,000,000 from the United States Department of Health and Human Services, Substance Abuse and Mental Health Services Administration (SAMHSA), to fund the FSM's Department of Health and Social Affairs System of Care (SOC) Expansion and Sustainability Project, including all the terms and conditions of the assistance.

1 WHEREAS, this award reflects conditional approval of the
2 revised budget submitted June 18, 2020, by the FSM, and was
3 granted through a Notice of Award; and

4 WHEREAS, the fund amount from the U.S. Department of Health
5 and Human Services, SAMHSA is \$1,000,000; and

6 WHEREAS, the purpose of this grant is mainly to fund
7 treatment and prevention services for children ages 0-21 years old
8 throughout the FSM through the State BHWP offices; and

9 WHEREAS, section 210(2) title 55 of the Code of the Federated
10 States of Micronesia (Annotated), as amended, requires that for
11 foreign financial assistance to be valid it must be approved by
12 Congress by resolution; now, therefore,

13 BE IT RESOLVED by the Twenty-First Congress of the Federated
14 States of Micronesia, Fifth Regular Session, 2020, that Congress
15 hereby approves and accepts the \$1,000,000 grant from the U.S.
16 Department of Health and Human Services, Substance Abuse and
17 Mental Health Services Administration, to fund the System of Care
18 Expansion and Sustainability Project in the FSM; and


