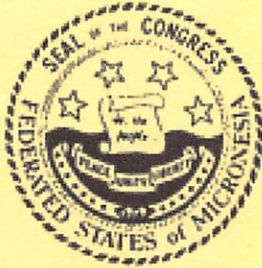

A RESOLUTION

To approve and accept a \$1,040,849.22 grant from the U.S. Department of Education, Office of Special Education, to fund the FSM Special Education Program for the Federal Fiscal Year 2020 under Part B of the Individuals with Disabilities Education Act, including all the terms and conditions of the assistance.

1           WHEREAS, the U.S. Department of Education issued a Grant  
2 Award on July 01, 2020, to the Government of the Federated States  
3 of Micronesia providing funding in the amount of \$1,040,849.22 for  
4 the purpose of providing support to the FSM Special Education  
5 Program for Federal Fiscal Year 2020 under Part B of the  
6 Individuals with Disabilities Education Act (IDEA Part B); and

7           WHEREAS, the Government of the Federated States of Micronesia  
8 wishes to express its appreciation and gratitude to the U.S.  
9 Government for extending this grant; and


10          WHEREAS, section 210(2) of title 55 of the Code of the  
11 Federated States of Micronesia (Annotated), as amended, requires  
12 that for foreign financial assistance to be valid it must be  
13 approved by Congress by resolution; now, therefore,

14          WHEREAS, by the Congress Twenty-First of the Federated States  
15 of Micronesia, Fifth Regular Session, 2020, that Congress hereby  
16 approves and accepts \$1,040,849.22 grant from U.S. Department of  
17 Education, Office of Special Education, to fund the FSM Special  
18 Education Program for the Federal Fiscal Year 2020 under Part B of  
19 the Individuals with Disabilities Education Act, including all the  
20 terms and conditions thereof; and


1 BE FURTHER RESOLVED that certified copies of this resolution
