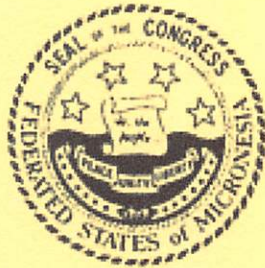

A RESOLUTION

Approving and accepting a grant from the United States Department of Health and Human Services, Public Health Services Administration, in the amount of \$160,000, to support and fund the FSM Department of Health and Social Affairs' Family Planning Program, including all the terms and conditions of the assistance.

1 WHEREAS, on September 14, 2020, the United States Department
2 of Health and Human Services, Public Health Services
3 Administration, issued a Notice of Award in the amount of
4 \$160,000, to fund and support the FSM Department of Health and
5 Social Affairs' Family Planning Program and its services for the
6 budget period from April 1, 2020 to March 31, 2021; and

7 WHEREAS, the purpose of this grant is to support the
8 implementation of the FSM Family Planning Program, to ensure
9 accessibility of an effective contraceptive of choice and to
10 improve the overall health status of women of child-bearing age in
11 the FSM; and

12 WHEREAS, this is a foreign financial assistance as defined
13 under section 210(1)(b) of title 55 of the Code of the Federated
14 States (Annotated), as amended; and

15 WHEREAS, section 210(2) title 55 of the Code of the Federated
16 States of Micronesia (Annotated), as amended, requires that for
17 foreign financial assistance to be valid it must be approved by
18 Congress by resolution; now, therefore,

19 BE IT RESOLVED by the Twenty-First Congress of the Federated
20 States of Micronesia, Eighth Special Session, 2020, that Congress


1 hereby approves and accepts the \$160,000 grant from the U.S.
2 Department of Health and Human Services, Public Health Services
3 Administration, to fund and support the FSM Department of Health
4 and Social Affairs' Family Planning Program, including all the
5 terms and conditions thereof; and

6 BE IT FURTHER RESOLVED that certified copies of this
7 resolution be transmitted to the President of the Federated States
8 of Micronesia, the Secretary of the Department of Health and
9 Social Affairs, the Secretary of the Department of Finance and
10 Administration and the Secretary of the Department of Justice.
