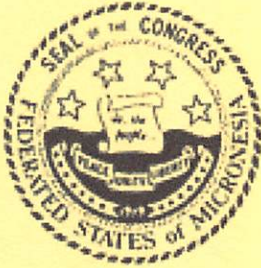

A RESOLUTION

Approving and accepting a grant in the amount of \$181,052 from the U.S. Department of Health and Human Services, Substance Abuse and Mental Health Services Administration, to fund and support the FSM Department of Health and Social Affairs and its Behavioral Health and Wellness Program (BHWP) for the Community Mental Health Services (CMHS) Project, including all the terms and conditions of the assistance.

1 WHEREAS, on September 25, 2020, the United States Department
2 of Health and Human Services, Substance Abuse and Mental Health
3 Services Administration, issued a notice of supplemental grant
4 award in the amount of \$181,052, to fund and support the FSM
5 Department of Health and Social Affairs and its Behavioral Health
6 and Wellness Program (BHWP) for the Community Mental Health
7 Services (CMHS) Project; and

8 WHEREAS, the purpose of this grant is to support the FSM and
9 its Department of Health and Social Affairs by funding technical
10 assistance and training activities related to serving the MHBG
11 target population, which includes adults with serious mental
12 health illness and children with serious emotional disturbances
13 throughout the FSM; and

14 WHEREAS, the budget period for this supplemental grant award
15 is from October 1, 2020 to September 30, 2021; and

16 WHEREAS, this grant will also assist the FSM Department of
17 Health and Social Affairs in its efforts toward the reduction of
18 health-related mortality in the FSM; and

19 WHEREAS, this is a foreign financial assistance as defined

1 under Section 210(1)(b) of title 55 of the Code of the Federated
2 States of Micronesia (Annotated), as amended; and

3 WHEREAS, section 210(2) of title 55 of the Code of the
4 Federated States of Micronesia (Annotated), as amended, requires
5 that for foreign financial assistance to be valid it must be
6 approved by Congress by resolution, now, therefore,

7 BE IT RESOLVED by the Twenty-First Congress of the Federated
8 States of Micronesia, Eighth Special Session, 2020, that Congress
9 hereby approves and accepts the \$181,052 grant from U.S.
10 Department of Health and Human services, Substance Abuse and
11 Mental Health Services Administration, to fund and support the FSM
12 Department of Health and Social Affairs in its Community Mental
13 Health Services Program, including all the terms and conditions
14 thereof; and


