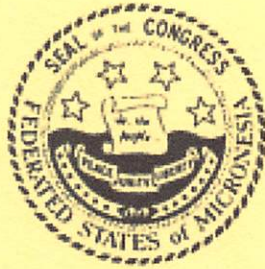

A RESOLUTION

Approving and accepting a grant from the United States Department of Health and Human Services, Health Resources and Services Administration (HRSA) in the amount of \$187,388, to fund and support the Maternal and Child Health Services Program of the FSM Department of Health and Social Affairs, including all the terms and conditions of the assistance.

1 WHEREAS, on March 23, 2020, the United States Department of
2 Health and Human Services, Health Resources and Services
3 Administration (HRSA), issued a notice of grant award in the
4 amount of \$187,388, to fund and support the Maternal and Child
5 Health Services Program; and

6 WHEREAS, the Government of the Federated States of Micronesia
7 wishes to express its sincere gratitude and appreciation to the
8 Government of the United States of America for this generous
9 grant; and

10 WHEREAS, the purpose of this grant is to support the FSM and
11 its Department of Health and Social Affairs by providing partial
12 funding for the Fiscal Year 2020 Maternal and Child Health
13 Services Program; and

14 WHEREAS, the program period and budget period for this grant
15 award is from October 1, 2019 to September 30, 2021; and

16 WHEREAS, this is a foreign financial assistance as defined
17 under section 210(1)(b) of title 55 of the Code of the Federated
18 States of Micronesia (Annotated), as amended; and

19 WHEREAS, section 210(2) of title 55 of the Code of the
20 Federated States of Micronesia (Annotated), as amended, requires

1 that for foreign financial assistance to be valid it must be
2 approved by Congress by resolution, now, therefore,

3 BE IT RESOLVED by the Twenty-First Congress of the Federated
4 States of Micronesia, Eighth Special Session, 2020, that Congress
5 hereby approves and accepts the \$187,388 grant from the U.S.
6 Department of Health and Human Services, Health Resources and
7 Services Administration, to fund and support the Maternal and
8 Child Health Services Program of the FSM Department of Health and
9 Social Affairs, including all the terms and conditions thereof;
10 and

11 BE IT FURTHER RESOLVED that certified copies of this
12 resolution be transmitted to the President of the Federated States
13 of Micronesia, the Secretary of the Department of Health and
14 Social Affairs, the Secretary of the Department of Finance and
15 Administration and the Secretary of the Department of Justice.




