A RESOLUTION

Approving and accepting a grant from the United States Department of Education, Office of Special Education Programs, in the amount of \$2,844,888.90, to fund and support the FSM Special Education Program under Part B of the Individuals with Disabilities Education Act, including all the terms and conditions of the assistance.

1 WHEREAS, on October 1, 2020, the United States Department of
2 Education, Office of Special Education Programs, issued a Grant
3 Award in the amount of \$2,844,888.90, to fund and support the FSM
4 Special Education Program under Part B of the Individuals with
5 Disabilities Education Act; and

6 WHEREAS, the budget period for this grant award is from July
7 1, 2020 to September 30, 2021; and

8 WHEREAS, the Government of the Federated States of Micronesia
9 wishes to express its sincere appreciation and gratitude to the
10 Government of the United States for this generous grant; and

11 WHEREAS, this is a foreign financial assistance as defined
12 under section 210(1)(b) of title 55 of the Code of the Federated
13 States of Micronesia (Annotated), as amended; and

14 WHEREAS, section 210(2) of title 55 of the Code of the
15 Federated States of Micronesia (Annotated), as amended, requires
16 that for foreign financial assistance to be valid it must be
17 approved by Congress by resolution, now, therefore,

18 BE IT RESOLVED by the Twenty-First Congress of the Federated
19 States of Micronesia, Eighth Special Session, 2020, that Congress
20 hereby approves and accepts the \$2,844,888.90 grant from the U.S.

1 Department of Education, Office of Special Education Programs, to
2 fund and support the FSM Special Education Program under Part B of
3 the Individuals with Disabilities Education Act, including all the
4 terms and conditions thereof; and

5 BE IT FURTHER RESOLVED that certified copies of this
6 resolution be transmitted to the President of the Federated States
7 of Micronesia, the Secretary of the Department of Education, the
8 Secretary of the Department of Finance and Administration, the
9 Secretary of the Department of Foreign Affairs, and the Secretary
10 of the Department of Justice.
