Authorizing the President to resubmit the nomination of Mr. Carlson D. Apis to serve as a member of the FSM Telecommunication Corporation, representing the National Government.

1           WHEREAS, during the Seventh Special Session of the Twenty-  
2 First Congress the President submitted the nomination of Mr.  
3 Carlson D. Apis to serve as a member of the FSM Telecommunication  
4 Corporation, representing the National Government; and

5           WHEREAS, Congress did not take action within two sessions of  
6 Congress; and

7           WHEREAS, the resolution approving the nomination has been  
8 deemed rejected, and under 2 F.S.M.C. §207(3) the nomination  
9 may not be resubmitted by the President during the Twenty-  
10 First Congress without authorization by Congress; now,  
11 therefore,

12           BE IT RESOLVED by the Twenty-First Congress of the  
13 Federated States of Micronesia, Ninth Special Session, 2020,  
14 that Congress hereby authorizes the President to resubmit the  
15 nomination of Mr. Carlson D. Apis to serve as a member of the  
16 FSM Telecommunication Corporation, representing the National  
17 Government; and


