A RESOLUTION

Approving and accepting a grant in the amount of \$1,472,380 from the U.S. Department of Health and Human Services, Centers for Disease Control and Prevention, to fund the FSM Immunization and Vaccines for Children Program, including all the terms and conditions of the assistance.

1 WHEREAS, the U.S. Department of Health and Human Services,
2 Centers for Disease Control and Prevention, issued a Notice of
3 Award of financial assistance on June 18, 2019, in the amount of
4 \$1,472,380 and

5 WHEREAS, the purpose of the grant is to support the FSM
6 Department of Health and Social Affairs Immunization and Vaccines
7 for Children Program; and

8 WHEREAS, section 210(2) of title 55 of the Code of the
9 Federated States of Micronesia (Annotated), as amended, provides
10 that for foreign financial assistance to be valid it must be
11 approved by Congress by resolution; and

12 WHEREAS, the FSM Government expresses appreciation to the
13 United States Government for the federal grant programs made
14 available to the Federated States of Micronesia; now, therefore,

15 BE IT RESOLVED by the Twenty-First Congress of the Federated
16 States of Micronesia, Second Special Session, 2019, that Congress
17 hereby approves and accepts the \$1,472,380 grant from the U.S.
18 Department of Health and Human Services, Centers for Disease
19 Control and Prevention, to fund the FSM Immunization and Vaccines
20 for Children Program, including all the terms and conditions

1 thereof; and

2 BE IT FURTHER RESOLVED that certified copies of this
3 resolution be transmitted to the President of the Federated States
4 of Micronesia, the Secretary of the Department of Health and
5 Social Affairs and the United States Embassy in Kolonia.


