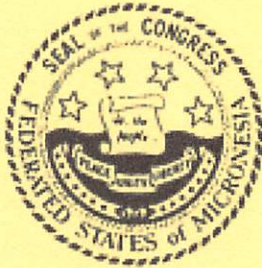

A RESOLUTION

Approving and accepting a grant from the United States Department of Health and Human Services, Health Resources and Services Administration, in the amount of \$102,499, to fund and support the Maternal and Child Health Services Program of the FSM Department of Health and Social Affairs, including all the terms and conditions of the assistance.

1           WHEREAS, on October 26, 2020, the United States Department of  
2 Health and Human Services, Health Resources and Services  
3 Administration, issued a notice of grant award in the amount of  
4 \$102,499, to fund and support the Maternal and Child Health  
5 Services Program of the FSM Department of Health and Social  
6 Affairs; and

7           WHEREAS, the Government of the Federated States of Micronesia  
8 wishes to express its sincere gratitude and appreciation to  
9 Government of the United States of America for this generous  
10 grant; and

11           WHEREAS, the purpose of this grant is to support the FSM and  
12 its Department of Health and Social Affairs by providing funding  
13 for the first quarter of the fiscal year 2021 Maternal and Child  
14 Health Services Program; and

15           WHEREAS, the project period is from October 1, 2020 to  
16 September 30, 2022; and

17           WHEREAS, this is a foreign financial assistance as defined  
18 under section 210(1)(b) of title 55 of the Code of the Federated  
19 States of Micronesia (Annotated), as amended; and

20           WHEREAS, section 210(2) of title 55 of the Code of the

1 Federated States of Micronesia (Annotated), as amended, requires  
2 that for foreign financial assistance to be valid it must be  
3 approved by Congress by resolution, now, therefore,

4 BE IT RESOLVED by the Twenty-First Congress of the Federated  
5 States of Micronesia, Ninth Special Session, 2020, that Congress  
6 hereby approves and accepts the \$102,499, grant from the U.S.  
7 Department of Health and Human Services, Health Resources and  
8 Services Administration, to fund and support the Maternal and  
9 Child Health Services Program of the FSM Department of Health and  
10 Social Affairs, including all the terms and conditions thereof;  
11 and

12 BE IT FURTHER RESOLVED that certified copies of this  
13 resolution be transmitted to the President of the Federated States  
14 of Micronesia, the Secretary of the Department of Health and  
15 Social Affairs, the Secretary of the Department of Finance and  
16 Administration and the Secretary of the Department of Justice.


