A RESOLUTION

Approving and accepting a grant in the amount of \$130,000 from the U.S. Department of Health and Human Services, Health Resources and Services Administration, to fund and support the Emergency Medical Services for Children Program in the FSM, including all the terms and conditions of the assistance.

1 WHEREAS, on April 22, 2019, the United States through the
2 Department of Health and Human Services, Health Resources and
3 Services Administration, extended to the Government of the
4 Federated States of Micronesia in grant in the amount of \$130,000
5 as evidence by a Notice of Grant No. H33MC25687-07-00; and

6 WHEREAS, the grant was awarded for the specific purpose of
7 funding the FSM Emergency Medical Services for Children Program in
8 order to reduce the prevalence of pediatric morbidity that may
9 occur as a result of acute illness and severe injury; and

10 WHEREAS, section 210(2) of title 55 of the Code of the
11 Federated States of Micronesia (Annotated), as amended, provides
12 that for foreign financial assistance to be valid it must be
13 approved by Congress by resolution; now, therefore,

14 BE IT RESOLVED by the Twenty-First Congress of the Federated
15 States of Micronesia, Second Special Session, 2019, that Congress
16 hereby approves and accepts the \$130,000 grant from the U.S.
17 Department of Health and Human Services, Health Resources and
18 Services Administration, to fund the FSM Emergency Medical
19 Services for Children Program, including all the terms and
20 conditions thereof; and

1 BE IT FURTHER RESOLVED that certified copies of this
2 resolution be transmitted to the President of the Federated States
3 of Micronesia, the Secretary of the Department of Health and
4 Social Affairs and the United States Embassy in Kolonia.
