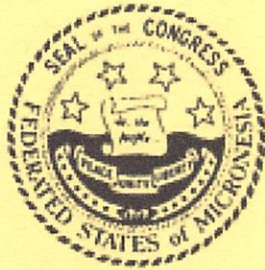

A RESOLUTION

Approving and accepting a grant in the amount of \$6,000,000 from the Asian Development Bank, giving funding to the Federated States of Micronesia under the Pacific Disaster Resilience Program – Phase 3, including all the terms and conditions of the assistance.

1 WHEREAS, the FSM Government and the Asian Development Bank
2 entered into a grant agreement dated December 11, 2020, giving the
3 FSM Government \$6,000,000 in funding to strengthen the FSM's
4 resilience to disasters caused by natural hazards and health
5 related emergencies; and

6 WHEREAS, this grant is considered as a foreign financial
7 assistance that requires for its validity the approval by Congress
8 through a resolution; and

9 WHEREAS, that the Government of the Federated States of
10 Micronesia wishes to express its appreciation and gratitude to the
11 Asian Development Bank for this generous assistance;

12 BE IT RESOLVED by the Twenty-First Congress of the Federated
13 States of Micronesia, Sixth Regular Session, 2021, that Congress
14 hereby approves and accepts the \$6,000,000 grant from the Asian
15 Development Bank giving funding to the FSM under the Pacific
16 Disaster Resilience Program-Phase 3; including all the terms and


