A RESOLUTION

Approving and accepting a grant from the United States Department of Health and Human Services, Centers for Disease Control and Prevention, in the amount of \$821,849, to fund and support the Communicable Disease Prevention and Control Project of the FSM's Department of Health and Social Affairs, including all the terms and conditions of the grant.

1 WHEREAS, on December 3, 2020, the United States Department of
2 Health and Human Services, Centers for Disease Control and
3 Prevention, issued a Notice of Grant Award No. 5 NU62PS910167-04-
4 00, in the amount of \$821,849, to fund and support the
5 Communicable Disease Prevention and Control Project of the FSM's
6 Department of health and Social Affairs; and

7 WHEREAS, the Government of the Federated States of Micronesia
8 wishes to express its sincere gratitude and appreciation to the
9 Government of the United States of America for this generous
10 grant; and

11 WHEREAS, the purpose of this grant is to support the FSM
12 Government and its Department of Health and Social Affairs by
13 providing funding to support and accelerate the prevention and
14 control of HIV, Viral Hepatitis, Sexually Transmitted Disease and
15 Tuberculosis in the FSM; and

16 WHEREAS, the project period is from January 1, 2018 to
17 December 31, 2022, and the budget period for this grant award is
18 from January 1, 2021, to December 31, 2021; and

19 WHEREAS, this foreign financial assistance as defined under
20 section 210(2) of title 55 of the Code of the Federated States of

1 Micronesia (Annotated), as amended; and

2 WHEREAS, section 210(2) of title 55 of the Code of the
3 Federated States of Micronesia (Annotated), as amended, requires
4 that in order for foreign financial assistance to be valid it must
5 be approved by Congress by resolution; now, therefore,

6 BE IT RESOLVED by the Twenty-First Congress of the Federated
7 States of Micronesia, Sixth Regular Session, 2021, that Congress
8 hereby approves and accepts this \$821,849 grant from the U.S.
9 Department of Health and Human Services, Centers for Disease
10 Control and Prevention, to fund and support the Communicable
11 Disease Prevention and Control Project of the FSM's Department of
12 Health and Social Affairs, including all the terms and conditions
13 thereof; and
