To approve and accept a \$12,760,000 grant from the Asian Development Bank (ADB) to provide funding for the Chuuk Water Supply and Sanitation Project, including all the terms and conditions of the assistance.

1 WHEREAS, the ADB issued a grant award on December 4, 2020, to
2 the Government of the Federated States of Micronesia providing
3 funding in the amount of \$12,760,000 for the Chuuk Water Supply
4 and Sanitation Project; and

6 assistance that requires for its validity the approval by Congress
7 through a resolution; and

8 WHEREAS, that the Government of the Federated States of
9 Micronesia wishes to express its appreciation and gratitude to the
10 ADB for extending this grant; now, therefore,

11 BE IT RESOLVED by the Twenty-First Congress of the Federated
12 States of Micronesia, Sixth Regular Session, 2021, that Congress
13 hereby approves the \$12,760,000 grant from the ADB to fund the
14 Chuuk Water Supply and Sanitation Project, including all the terms




