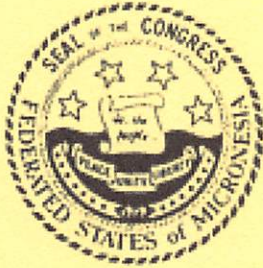

Approving and accepting a grant in the amount of \$40,000 from the United Nations Development Programme, to fund the Legislative Improvement Programme, for the budget period from October 01, 2021, to September 30, 2022, including all the terms and conditions of the assistance.

1 WHEREAS, the United Nations Development Programme issued a
2 grant award in the amount of \$40,000; and

3 WHEREAS, the purpose of the grant is to continue funding the
4 project entitled: "Legislative Improvement Programme" including
5 computer equipment; and

6 WHEREAS, section 210 (2) of title 55 of the Code of the
7 Federated States of Micronesia (Annotated), as amended, provides
8 that for an agreement on foreign financial assistance to be valid
9 it must be approved by Congress by resolution; and

10 WHEREAS, the FSM Government expresses appreciation to the
11 United Nations Development Programme for the grant award made
12 available to the Federated States of Micronesia; now, therefore,

13 BE IT RESOLVED by the Twenty-First Congress of the Federated
14 States of Micronesia, Sixth Regular Session, 2021, that Congress
15 hereby approves and accepts the \$40,000 grant from the United
16 Nations Development Programme, to fund the Legislative Improvement
17 Programme, including all the terms and conditions thereof; and


1 BE IT FURTHER RESOLVED that certified copies of this
