Approving an application for a federal grant in the amount of \$625,000 and its submission to the Substance Abuse and Mental Health Services Agency of the U.S. Department of Health and Human Services, to fund the FSM DHSA Mental Health Awareness Training.

1 WHEREAS, the United States, Substance Abuse and Mental Health
2 Services Agency of the U.S. Department of Health and Human
3 Services, announced a funding opportunity for the FSM DHSA Mental
4 Health Awareness Training, which the FSM National Government could
5 avail to support its program; and

6 WHEREAS, the FSM Department of Health and Social Affairs
7 developed an application for funding to fund various activities in
8 connection with the Mental Health Awareness Training; and

9 WHEREAS, in accordance with section 210(2)(c) of title 55 of
10 the FSM Code (Annotated), as amended, any first-time application
11 for foreign financial assistance shall require the approval by
12 Congress through resolution; now, therefore,

13 BE IT RESOLVED by the Twenty-First Congress of the Federated
14 States of Micronesia, Tenth Special Session, 2021, that Congress
15 here approves the submission of the grant application in the
16 amount of \$625,000 to the United States Department of Health and
17 Human Services to fund the FSM DHSA Mental Health Awareness
