A RESOLUTION

Approving and accepting a grant in the amount of \$240,150 from the U.S. Department of Interior, Office of Insular Affairs, to fund the National Public Auditor Training Program, including all the terms and conditions of the assistance.

1 WHEREAS, on June 27, 2019, the U.S. Department of Interior,
2 Office of Insular Affairs, issued a grant award to the Federated
3 States of Micronesia in the amount of \$240,150; and

4 WHEREAS, the purpose of the grant is to provide funding for
5 the National Public Auditor Training Program; and

6 WHEREAS, section 210(2) of title 55 of the Code of the
7 Federated States of Micronesia (Annotated), as amended, provides
8 that for foreign financial assistance to be valid it must be
9 approved by Congress by resolution; and

10 WHEREAS, the Government of the Federated States of
11 Micronesia wishes to express its appreciation to the Government of
12 the United States for the federal grant programs made available to
13 the FSM; now, therefore,


14 BE IT RESOLVED by the Twenty-First Congress of the Federated
