A RESOLUTION

Approving and accepting a grant from the United States Department of the Interior, Division of National Register Programs, National Park Service, in the amount of \$436,317, to fund and support the FSM National and State Historic Preservation Offices (HPO's) for the fiscal year 2019, including all the terms and conditions of the assistance.

1       WHEREAS, on August 31, 2020, the United States Department of  
2 the Interior, Division of National Register Programs, National  
3 Park Service, issued a Notice of Award No. P19AF00228 to the  
4 Government of the Federated States of Micronesia, to fund and  
5 support the FSM National and State Historic Preservation Offices  
6 (HPO's) for the fiscal year 2019; and

7       WHEREAS, the Government of the Federated States of Micronesia  
8 wishes to express its sincere gratitude and appreciation to the  
9 Government of the United States of America for this generous  
10 grant; and

11       WHEREAS, the period of performance for this grant is from  
12 January 1, 2021 to September 30, 2022; and

13       WHEREAS, this is a foreign financial assistance as defined  
14 under section 210(1)(b) of title 55 of the Code of the Federated  
15 States of Micronesia (Annotated), as amended, and

16       WHEREAS, section 210(2) of title 55 of the Code of the  
17 Federated States of Micronesia (Annotated), as amended, requires  
18 that for foreign financial assistance to be valid it must be  
19 approved by Congress by resolution; now, therefore,

20       BE IT RESOLVED by the Twenty-First Congress of the Federated

1 States of Micronesia, Tenth Special Session, 2021, that Congress  
2 hereby approves and accepts this \$436,317 grant from the United  
3 States Department of Interior, Division of National Register  
4 Programs, National Park Service, to fund and support the FSM  
5 National and State Historic Preservation Offices (HPO's) for the  
6 fiscal year 2019, including all the terms and conditions thereof;  
7 and

8 BE IT FURTHER RESOLVED that certified copies of this  
9 resolution be transmitted to the President of the Federated States  
10 of Micronesia, the Secretary of the Department of Finance and  
11 Administration, the Secretary of the Department of Foreign  
12 Affairs, the Secretary of the Department of Justice, and the  
13 Director of the Office of National Archives, Culture & Historic  
14 Preservation.
