A RESOLUTION

Approving and accepting a grant from the United States Department of the Interior, Office of Insular Affairs (DOI-OIA), in the amount of \$500,000, to fund and support the FSM's FY2020 Single Audit, including all the terms and conditions of the assistance.

1 WHEREAS, on October 10, 2020, the U.S. Department of
2 Interior, Office of Insular Affairs (OIA), issued a Notice of
3 Award No. D21AF00023, in the amount of \$500,000, to fund and
4 support the FSM's FY2020 Single Audit; and

5 WHEREAS, the Government of the Federated States Micronesia
6 wishes to express its sincere gratitude and appreciation to the
7 Government of the United States of America for this generous
8 grant; and

9 WHEREAS, the period of performance for this grant is from
10 October 1, 2020 to December 21, 2021, after which date all funds
11 not drawn down will be de-obligated; and

12 WHEREAS, this is a foreign financial assistance as defined
13 under section 210(1)(b) of Title 55 of the Code of the Federated
14 States of Micronesia (Annotated), as amended, and

15 WHEREAS, section 210(2) of title 55 of the Code of the
16 Federated States of Micronesia (Annotated), as amended, requires
17 that for foreign financial assistance to be valid it must be
18 approved by Congress by resolution; now, therefore,

19 BE IT RESOLVED by the Twenty-First Congress of the Federated
20 States of Micronesia, Tenth Special Session, 2021, that Congress
21 hereby approves and accepts the \$500,000 grant from the U.S. DOI-

1 OIA, to fund and support the FSM's FY2020 Single Audit, including
2 all the terms and conditions thereof; and

3 BE IT FURTHER RESOLVED that certified copies of this
4 resolution be transmitted to the President of the Federated States
5 of Micronesia, the National Public Auditor, the Secretary of the
6 Department of Finance and Administration, the Secretary of the
7 Department of Foreign Affairs, and the Secretary of the Department
8 of Justice.
