A RESOLUTION

Approving and accepting a grant from the United Nations Children's Fund (UNICEF) in the amount of \$1,652,655, to fund and support the FSM Department of Health and Social Affairs in the implementation of the various health and social programs and in carrying out the Rolling Work Plan with UNICEF, including all the terms and conditions of the assistance.

1           WHEREAS, on May 15, 2020, the United Nations Children's Fund  
2 (UNICEF) and the Government of the Federated States of Micronesia  
3 executed the 2020-2021 Rolling Work Plan, the duration of which is  
4 from January 1, 2020 to December 31, 2021; and

5           WHEREAS, the total amount planned for this Rolling Work Plan  
6 is \$3,056,570, and the total already spent for this Rolling Work  
7 Plan is \$1,403,915; and

8           WHEREAS, UNICEF is extending to the Government of the  
9 Federated States of Micronesia additional funding in the amount of  
10 \$1,652,655 for the remainder of the Rolling Work Plan; and

11           WHEREAS, the purpose of this grant is to fund and support the  
12 FSM in implementation of various health and social programs in the  
13 FSM and in carrying out the Rolling Work Plan with UNICEF; and

14           WHEREAS, the Government of the Federated States of  
15 Micronesia wishes to express its sincere gratitude and  
16 appreciation to UNICEF for this generous grant; and

17           WHEREAS, section 210(2) of title 55 of the Code of the  
18 Federated States of Micronesia (Annotated), as amended, requires  
19 that for foreign financial assistance to be valid it must be  
20 approved by Congress by resolution; now, therefore,

1 BE IT RESOLVED by the Twenty-First Congress of the Federated  
2 States of Micronesia, Tenth Special Session, 2021, that Congress  
3 hereby approves and accepts the grant in the amount of \$1,652,655  
4 from the United Nations Children's Fund (UNICEF), to fund and  
5 support FSM in the implementation of various health and social  
6 programs and in carrying out the Rolling Work with UNICEF; and

7 BE IT FURTHER RESOLVED that certified copies of this  
8 resolution be transmitted to the President of the Federated States  
9 of Micronesia, the Secretary of the Department of Health and  
10 Social Affairs, the Secretary of the Department of Finance and  
11 Administration, the Secretary of the Department of Foreign  
12 Affairs, and the Secretary of the Department of Justice.
