A RESOLUTION

Approving and accepting a grant from the United Nations Development Programme (UNDP) in the amount of \$380,693.55, to fund and support FSM Department of Health and Social Affairs in its efforts relating to HIV and TB prevention, diagnosis, treatment, care, management and support, including all the terms and conditions of the assistance.

1 WHEREAS, on December 14, 2020, the United Nations Development
2 Programme (UNDP), signed a grant agreement with the Global Fund to
3 continue the Multi-Country Western Pacific Integrated HIV/TB
4 Programme from 2021-2023; and

5 WHEREAS, FSM Department of Health and Social Affairs is one
6 of the sub-recipients under the Multi-Country Western Pacific
7 Integrated HIV/TB grant; and

8 WHEREAS, on February 1, 2021, UNDP and FSM Department of
9 Health and Social Affairs signed a grant agreement with a total
10 allocation of \$144,089.27 for the year 2021; and

11 WHEREAS, UNDP's Assurance Letter No. 009/2021 assures that
12 according to the approved work plan and budget for 2021-2023, the
13 FSM Department of Health and Social Affairs has been allocated
14 additional funding in the amount of \$126,552.14 for the year 2022
15 and \$110,052.14 for the year 2023, which has been endorsed by the
16 Pacific Islands Regional Multi-Country Coordinating Mechanism
17 (PIRCCM) and approved by the Global Fund; and

18 WHEREAS, the purpose of this grant is to assist the FSM
19 Government in HIV and TB prevention, diagnosis, treatment, care,
20 management and support from 2021 to 2023; and

1 BE IT FURTHER RESOLVED that certified copies of this
2 resolution be transmitted to the President of the Federated States
3 of Micronesia, the Secretary of the Department of Health and
4 Social Affairs, the Secretary of the Department of Finance and
5 Administration, the Secretary of the Department of Foreign
6 Affairs, and the Secretary of the Department of Justice.
