A RESOLUTION

Approving and accepting a grant from the United States Department of Health and Human Services, Centers for Disease Control and Prevention (CDC), in the amount of \$394,746, to fund and support the FSM Department of Health and Social Affairs in its efforts relating to the prevention and control of chronic disease and associated risk factors, including all the terms and conditions of the assistance.

1 WHEREAS, on February 11, 2021, the United States Department
2 of Health and Human Services, Centers for Disease Control and
3 Prevention (CDC), issued a Notice of Grant Award No.
4 5NU58DP006667-03-00, in the amount of \$394,746 to fund and support
5 the FSM Department of Health and Social Affairs in its activities
6 under the project titled: "Prevention and Control of Chronic
7 Disease and Associated Risk Factors in the U.S. Affiliated Pacific
8 Islands, U.S. Virginia Islands, and Puerto Rico - 2019"; and

9 WHEREAS, the government of the Federated States of Micronesia
10 wishes to express its appreciation and gratitude to the U.S. CDC
11 and the Government of the United States of America for this
12 generous grant; and

13 WHEREAS, the purpose of this grant is to support the FSM
14 Department of Health and Social Affairs by providing funding to
15 support prevention and control of chronic disease and associated
16 risk factors in the FSM; and

17 WHEREAS, this project is a five-year project starting from
18 March 29, 2019 to March 28, 2024, and this grant is for the third
19 year of the project with the budget period starting from March 29,
20 2021 to March 28, 2022; and

1 WHEREAS, section 210(2) of title 55 of the Code of the
2 Federated States of Micronesia (Annotated), as amended, provides
3 that for foreign financial assistance to be valid it must be
4 approved by Congress by resolution; now, therefore,

5 BE IT RESOLVED by the Twenty-First Congress of the Federated
6 States of Micronesia, Tenth Special Session, 2021, that Congress
7 hereby approves and accepts the \$394,746 grant from the U.S.
8 Department of Health and Human Services, Centers for Disease
9 Control and Prevention (CDC), to fund and support the FSM in its
10 efforts relating to prevention and control of chronic disease and
11 associated risk factors in the FSM; and


1 BE IT FURTHER RESOLVED that certified copies of this
