A RESOLUTION

Approving and accepting a grant in the amount of \$944,019 from the U.S. Department of Education for the Federal Fiscal Year 2019 under Part B of the Individual with Disabilities Education Act (IDEA), to fund the FSM Special Education Program, including all the terms and conditions of the assistance.

1 WHEREAS, the United States through the Department of
2 Education issued a Notice of Award on June 28, 2019, for the
3 federal funding period from July 01, 2019, to September 30, 2020,
4 in the amount of \$944,019; and

5 WHEREAS, the purpose of the grant is to fund and assist the
6 implementation of the FSM Special Education Program; and

7 WHEREAS, section 210(2) of title 55 of the Code of the
8 Federated States of Micronesia (Annotated), as amended, provides
9 that for foreign financial assistance to be valid it must be
10 approved by Congress by resolution; and

11 WHEREAS, the Government of the Federated States of Micronesia
12 wishes to express its appreciation to the Government of the United
13 States for the grant award; now, therefore,

14 BE IT RESOLVED by the Twenty-First Congress of the Federated
15 States of Micronesia, Second Special Session, 2019, that Congress
16 hereby approves and accepts the \$944,019 grant from the United
17 States Department of Education, to fund the FSM Special Education
18 Program, including all the terms and conditions thereof; and

4 U.S. Embassy in Kolonia.




