Approving and accepting a grant in the amount of \$282,682 from the U.S. Department of Health and Human Services, Centers for Disease Control and Prevention, to fund and support the FSM Hospital Preparedness Program for the fiscal year 2019, including all the terms and conditions of the assistance.

1           WHEREAS, on June 02, 2019, the U.S. Department of Health and  
2 Human Services, Centers for Disease Control and Prevention, issues  
3 a Notice of Award of financial assistance in the amount of  
4 \$282,682 to fund the Hospital Preparedness Program in the FSM; and

5           WHEREAS, the purpose of this grant is to fund the  
6 implementation of the Hospital Preparedness Program in responding  
7 to health emergencies and disaster; and

8           WHEREAS, section 210(2) of title 55 of the Code of the  
9 Federated States of Micronesia (Annotated), as amended, requires  
10 that for foreign financial assistance to be valid it must be  
11 approved by Congress by resolution; now, therefore,

12           BE IT RESOLVED by the Twenty-First Congress of the Federated  
13 States of Micronesia, Second Special Session, 2019, that Congress  
14 hereby approves and accepts the \$282,682 grant from the U.S.  
15 Department of Health and Human Services, Centers for Disease  
16 Control and Prevention, to fund the Hospital Preparedness Program  
17 in the FSM for the fiscal year 2019, including all the terms and  
18 conditions thereof; and

4 Social Affairs.


