A RESOLUTION

Requesting the President of the Federated States of Micronesia to establish an embassy for the Federated States of Micronesia in Canberra, Australia.

1 WHEREAS, the Federated States of Micronesia has a very
2 close relationship with Australia; and

3 WHEREAS, the Federated States of Micronesia has enjoyed
4 many educational, economic, development and social benefits
5 from its relationship with Australia; and

6 WHEREAS; Australia has for many years had an embassy in
7 the Federated States of Micronesia, but there is currently no
8 embassy of the Federated States of Micronesia in Australia, and

9 WHEREAS, the Congress of the Federated States of
10 Micronesia believes that it would further advance our Nation's
11 diplomatic ties with Australia by establishing an embassy in
12 Canberra, Australia; now, therefore,

13 BE IT RESOLVED by the Twenty First Congress of the
14 Federated States of Micronesia, Second Special Session, 2019,
15 that Congress hereby requests the President of the Federated
16 States of Micronesia by establishing an embassy for the
17 Federated States of Micronesia in Canberra, Australia;




