A RESOLUTION

Expressing the profound appreciation of the Twenty-First Congress of the Federated States of Micronesia to the Honorable Alik L. Alik for his dedication and public service to his nation.

1           WHEREAS, the Honorable Alik L. Alik, was the seventh Vice  
2 President of the Federated States of Micronesia who had dedicated  
3 years of public service; and

4           WHEREAS, the Honorable Alik L. Alik became a Foreign  
5 Service Officer for the FSM Department of External Affairs in  
6 1982 and was promoted to Deputy Chief for the Division of South  
7 Pacific Affairs; and

8           WHEREAS, the Honorable Alik L. Alik became the first  
9 Micronesian ambassador to Fiji and served until 1998 and while  
10 in Fiji he was also cross-accredited as FSM's Ambassador to  
11 Israel, Tonga, Nauru, Kiribati, Samoa, Tuvalu, the Solomon  
12 Islands and Vanuatu; and

13           WHEREAS, the Honorable Alik L. Alik was appointed  
14 ambassador to Japan in 1998 and while in Japan, he was also  
15 cross-accredited as the FSM's Ambassador to the People's  
16 Republic of China, South Korea, India, Malaysia, Indonesia and  
17 Singapore; and

18           WHEREAS, the Honorable Alik L. Alik began his political  
19 career in 2003, when he won Kosrae State's at-large  
20 representative to the 13th FSM Congress in which he held  
21 chairmanship for the Committee on Resource and Development with

1 membership on the Committees of Judiciary & Governmental  
2 Operations and also External Affairs; now, therefore,

3 BE IT RESOLVED by the Twenty-First Congress of the  
4 Federated States of Micronesia, Second Special Session, 2019,  
5 that Congress hereby expresses its profound appreciation to the  
6 Honorable Alik L. Alik for his leadership and immeasurable  
7 contributions to the Congress of the Federated States of  
8 Micronesia and his nation; and

9 BE IT FURTHER RESOLVED that certified copies of this  
10 resolution be transmitted to the President of the Federated  
11 States of Micronesia, the Governor of the State of Kosrae, and  
12 the Honorable Alik L. Alik.


