A RESOLUTION

To ratify the Agreement Between the Government of the Federated States of Micronesia and the Government of the Russian Federation on the Mutual Waiver of Visa Requirements (the "Agreement").

1           WHEREAS, the Federated States of Micronesia and the Russian  
2 Federation signed the Agreement on September 21, 2017, in New  
3 York; and

4           WHEREAS, the Agreement accords reciprocal privileges between  
5 the two countries on the waiver of visa requirements; and

6           WHEREAS, this visa-free privileges apply to a short stay in  
7 their respective territory for a period not exceeding 30 days;  
8 now, therefore,

9           BE IT RESOLVED by the Twenty-first Congress of the Federated  
10 States of Micronesia, Second Regular Session, 2019, that Congress  
11 hereby ratifies the Agreement Between the Government of the  
12 Federated States of Micronesia and the Government of the Russian  
13 Federation on the Mutual Waiver of Visa Requirements;




