1           WHEREAS, on June 30, 2019, the U.S. Department of Health and  
2 Human Services, Centers for Disease Control and Prevention issued  
3 a Notice of Award of financial assistance in the amount of  
4 \$467,114; and

5           WHEREAS, the purpose of this grant is to fund the  
6 implementation of the Public Health and Healthcare Emergency  
7 Preparedness Program to improve and support States Department of  
8 Health Services in responding to health emergencies and disasters;


10           WHEREAS, section 210(2) of title 55 of the Code of the

13 approved by Congress by resolution; now, therefore,

15 States of Micronesia, Second Regular Session, 2019, that Congress  
16 hereby approves and accepts the \$467,114 grant from the U.S.  
17 Department of Health and Human Services, Centers for Disease  
18 Control and Prevention, to fund the Public Health and Healthcare  
19 Emergency Preparedness Program in the FSM for the fiscal year  
20 2019, including all the terms and conditions thereof; and


1 BE IT FURTHER RESOLVED that certified copies of this
