A RESOLUTION

To confirm the nomination of Mr. Jackson T. Soram to serve as the FSM Deputy Chief of Mission to the United States of America in Washington, D.C.

1 WHEREAS, the President of the Federated States of
2 Micronesia has nominated Mr. Jackson Soram to serve as the FSM
3 Deputy Chief of Mission (DCM) to the United States of America;
4 and

5 WHEREAS, the nomination is subject to the advice and
6 consent of the Congress pursuant to Section 2(d), Article X, of
7 the Constitution of the Federated States of Micronesia and 2
8 F.S.M.C. §207; and

9 WHEREAS, Mr. Soram recently completed service in this
10 capacity as Deputy Chief of Mission in Washington D.C.; and

11 WHEREAS, he has held several other positions in the
12 National Government, including as acting Assistant Secretary of
13 the Asia, Pacific, Africa and Multilateral Affairs in the
14 Department of Foreign Affairs and as Deputy Chief of Mission in
15 Beijing, China; and

16 WHEREAS, Mr. Soram possesses the essential qualifications
17 making him a suitable candidate to once again serve as Deputy
18 Chief of Mission, now, therefore,

19 BE IT RESOLVED by the Twenty-First Congress of the
20 Federated States of Micronesia, Second Regular Session, 2019,

1 that Congress hereby confirms the nomination of Mr. Jackson T.
2 Soram to serve as the FSM Deputy Chief of Mission to the United
3 States of America in Washington, D.C.; and

4 BE IT FURTHER RESOLVED that certified copies of this
5 resolution be transmitted to the President of the Federated
6 States of Micronesia, the Governor of each state of the Nation,
7 and Mr. Jackson Soram.




