1 WHEREAS, the President of the Federated States of Micronesia
2 has nominated Mr. Jeem S. Lippwe to serve as the Deputy Permanent
3 Representative of the Federated States of Micronesia to the United
4 Nations in New York; and

5 WHEREAS, the nomination is subject to the advice and consent
6 of Congress pursuant to Section 2(d), Article X, of the
7 Constitution of the Federated States of Micronesia and title 2
8 F.S.M.C. §207; and

9 WHEREAS, having served in this capacity since 2005, and
10 previously in various capacities in the Department of Foreign
11 Affairs, Mr. Lippwe possesses the essential qualifications that
12 make him a suitable candidate to once again serve as the Deputy
13 Permanent Representative of the Federated States of Micronesia to
14 the United Nations; now, therefore,

15 BE IT RESOLVED by the Twenty-First Congress of the Federated
16 States of Micronesia, Second Regular Session, 2019, that Congress
17 hereby confirms the nomination of Mr. Jeem S. Lippwe to serve as
18 the Deputy Permanent Representative of the Federated States of
19 Micronesia to the United Nations; and

1 BE IT FURTHER RESOLVED that certified copies of this
2 resolution be transmitted to the President of the Federated States
3 of Micronesia, the Governor of each state of the Nation and Mr.
4 Jeem S. Lippwe.




