2 Micronesia has nominated Mr. Akillino Susaia to serve as the
3 FSM Ambassador Extraordinary Plenipotentiary to the United
4 States of America in Washington, D.C.; and

5 WHEREAS, the nomination is subject to the advice and
6 consent of Congress pursuant to Section 2(d), Article X of the
7 Constitution of the Federated States of Micronesia and 2
8 F.S.M.C. §207; and

9 WHEREAS, Mr. Susaia served in this capacity before and has
10 held several important positions in the FSM National
11 Government, including the FSM Ambassador to the People's
12 Republic of China, the Secretary of the Department of
13 Transportation Communications & Infrastructure, and the
14 Secretary of Economic Affairs within the of the Department of
15 Resources and Development; and

16 WHEREAS, Mr. Susaia is qualified to continue serving as
17 the ambassador to the United States; now, therefore,

18 BE IT RESOLVED by the Twenty-First Congress of the
19 Federated States of Micronesia, Second Regular Session, 2019,
20 that Congress hereby confirms the nomination of Mr. Akillino

1 Susaia to serve as the FSM Ambassador Extraordinary
2 Plenipotentiary to the United States of America in Washington,
3 D.C.; and

4 BE IT FURTHER RESOLVED that certified copies of this
5 resolution be transmitted to the President of the Federated
6 States of Micronesia, the Governor of each state of the Nation
7 Mr. Akillino Susaia.




