APPROVING AND ACCEPTING GRANT IN THE AMOUNT OF \$39,238 FROM THE UNITED NATIONS DEVELOPMENT PROGRAMME TO SUPPORT THE FSM'S EFFORTS IN MEETING ITS OBLIGATIONS UNDER THE CEDAW CONVENTION, PARTICULARLY TO ELIMINATE VIOLENCE AGAINST WOMEN IN ITS UNDP WORK PLAN OF 2019-2020, INCLUDING ALL THE TERMS AND CONDITIONS OF THE ASSISTANCE.

A RESOLUTION

Approving and accepting grant in the amount of \$39,238 from the United Nations Development Programme to support the FSM's efforts in meeting its obligations under the CEDAW Convention, particularly to eliminate violence against women in its UNDP work plan of 2019-2020, including all the terms and conditions of the assistance.

1 WHEREAS, the United Nations Development Programme (UNDP) is
2 providing a grant in the amount of \$39,238 to the Federated States
3 of Micronesia through the FSM-UNDP Programme of Cooperation 2019-
4 2020 as evidenced by a Letter of Assurance attached and signed on
5 August 30, 2019; and

6 WHEREAS, the purpose of the grant is to fund the
7 implementation of the following programs in the 2019-2020 work
8 plan 1: Elimination of Violence Against Women (EVAW), policy
9 consultation and validation workshop and support of M&E
10 development and 2: EVAW coordinator salary; and

11 WHEREAS, section 210(2) of title 55 of the Code of the
12 Federated States of Micronesia (Annotated), as amended, provides
13 that for foreign financial assistance to be valid it must be
14 approved by Congress by resolution; and

15 WHEREAS, the FSM Government expresses appreciation to the
16 United Nations Development Programme for funding these programs
17 and availing them to the Federated States of Micronesia; now,
18 therefore,

19 BE IT RESOLVED by the Twenty-First Congress of the Federated
20 States of Micronesia, Second Regular Session, 2019, that Congress

1 hereby approves and accepts the \$39,238 grant from the United
2 Nations Development Programme to support the FSM's effort in
3 meeting its obligations under the CEDAW Convention; including all
4 the terms and conditions thereof; and

5 BE IT FURTHER RESOLVED that certified copies of this
6 resolution be transmitted to the President of the Federated States
7 of Micronesia and the Secretary of the Department of Foreign
8 Affairs.


