2 First Congress the President submitted the nomination of Mr.
3 Livinson A. Taulung to serve as the Secretary of the Department

5 Micronesia; and

6 WHEREAS, the resolution approving that nomination has be
7 rejected and its reconsideration has also failed, and under 2
8 F.S.M.C. §207(3) the nomination may not be resubmitted by the
9 President during the Twenty-First Congress without
10 authorization by Congress; now, therefore,

11 BE IT RESOLVED by the Twenty-First Congress of the
12 Federated States of Micronesia, Second Regular Session, 2019,
13 that Congress hereby authorizes the President to resubmit the
14 nomination of Mr. Livinson A. Taulung to serve as the Secretary
15 of the Department of Health and Social Affairs of the Federated

4 and Mr. Livinson A. Taulung.




