1 WHEREAS, during the Second Regular Session of the Twenty-
2 First Congress the President submitted the nomination of Mr.
3 Eugene Amor to serve as the Secretary of the Department of
4 Finance and Administration of the Federated States of
5 Micronesia; and

6 WHEREAS, the resolution approving that nomination has be
7 rejected and its reconsideration has also failed, and under 2
8 F.S.M.C. §207(3) the nomination may not be resubmitted by the
9 President during the Twenty-First Congress without
10 authorization by Congress; now, therefore,

11 BE IT RESOLVED by the Twenty-First Congress of the
12 Federated States of Micronesia, Second Regular Session, 2019,
13 that Congress hereby authorizes the President to resubmit the
14 nomination of Mr. Eugene Amor to serve as the Secretary of the
15 Department of Finance and Administration of the Federated
16 States of Micronesia; and

4 and Mr. Eugene Amor.


