Authorizing the President to resubmit the nomination of Mr. Joses Gallen to serve as the Secretary for the Department of Justice of the Federated States of Micronesia.

1 WHEREAS, during the Second Regular Session of the Twenty-
2 First Congress the President submitted the nomination of Mr.
3 Joses Gallen to serve as the Secretary of the Department of
4 Justice of the Federated States of Micronesia; and

5 WHEREAS, the resolution approving that nomination has be
6 rejected and its reconsideration has also failed, and under 2
7 F.S.M.C. §207(3) the nomination may not be resubmitted by the
8 President during the Twenty-First Congress without
9 authorization by Congress; now, therefore,

10 BE IT RESOLVED by the Twenty-First Congress of the
11 Federated States of Micronesia, Second Regular Session, 2019,
12 that Congress hereby authorizes the President to resubmit the
13 nomination of Mr. Joses Gallen to serve as the Secretary of the
14 Department of Justice of the Federated States of Micronesia;

4 Joses Gallen.




