A BILL FOR AN ACT

To further amend Public Law No. 19-54, as amended by Public Laws Nos. 19-62, 19-75, 19-79, 19-99, 19-119, 20-04, 20-56, 20-82, 20-127, 21-20, 21-117, 21-169, 21-174, 21-194, 21-205 and 21-233, by amending sections 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein, to fund public projects and social programs in the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

accordance with applicable laws including, but not limited to, the applicable laws, including, but not limited to, the Financial Management Act of 1979. allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum The allottee of the funds appropriated appropriated. under section 2 of this act shall be the Governor of Yap The allottee of funds appropriated under State. sections 3 and 4 of this act shall be the President of the Federated States of Micronesia or his designee; PROVIDED THAT, the allottee of funds appropriated under subsections 3(a), (b), (c), (d), (e), (f), (g), (h), (t), (u), (v), (ag), (ar) and (as) of this act shall be the Mayor of Utwe Municipal Government or his designee; the allottee of funds appropriated under subsections 3(k), (w), (x), (y), (z), (aa), (ab), (ac), (ad), (ae), (af), (ah), (ai), (aj), (ak), (al), (am), (an), (ao), (ap) and (aq) of this act shall be the Mayor of Tafunsak Municipal Government or his designee; the allottee of funds appropriate under subsections [+] 4(1)(a), (b), (c), (e), (f), and 4(2) shall be the Secretary of the Department of Transportation, Communications and Infrastructure or his designee; the allottee of funds
