"Section 6. Allotment and management of funds and lapse All funds appropriated by this act shall be allotted, managed, administered and accounted for in accordance with applicable laws, including, but not limited to, the Financial Management Act of 1979. allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum appropriated. The allottee of the funds appropriated under section 2 of this act shall be the Governor of Yap State or his designee. The allottee of funds appropriated under section 3(1) of this act shall be the Governor of Kosrae State or his designee. The allotee of funds appropriated under section 3(2) shall be the Mayor Lelu Town Government or his designee. The allottee of funds appropriated under section 4 of this act shall be the President of the Federated States of Micronesia or his designee; EXCEPT THAT, the allottee of funds appropriated under subsection 4(1)(i) of this act shall be the Mayor of Pingelap Municipal Government; the allottee of funds appropriated under subsections 4(1)(c),

Utility Corporation (CPUC). The authority of the
allottee to obligate funds appropriated by this act shall
lapse on September 30, 2023."

President of the Federated States of Micronesia or upon its
becoming law without such approval.
