

A BILL FOR AN ACT

To further amend Public Law No. 18-117, as amended by Public Laws Nos. 18-120, 19-04, 19-08, 19-35, 19-49, 19-59, 19-76, 19-102, 20-26, 20-117, 21-27, 21-114, 21-166, 22-13, 22-71, 22-121 and 22-176, by amending sections 3 and 6 thereof, to change the use and allottee of funds previously appropriated therein, for the purpose of funding public projects and social programs for the people in the state of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 18-117, as amended by
2 Public Laws Nos. 18-120, 19-04, 19-08, 22-71 and 22-176, is hereby
3 further amended to read as follows:

4 "Section 3. Of the sum of \$2,800,000 appropriated by this
5 act, \$400,000 is apportioned for Kosrae State for public
6 projects and social programs.

10 Section 2. Section 6 of Public Law No. 18-117, as amended
 11 by Public Laws Nos. 19-04, 19-59, 19-102, 20-26, 20-117, 21-27,
 12 21-166, 22-13, 22-121 and 22-176, is hereby further amended to
 13 read as follows:

14 "Section 6. Allotment and management of funds and lapse
 15 date. All funds appropriated by this act shall be
 16 allotted, managed, administered and accounted for in
 17 accordance with applicable laws, including, but not
 18 limited to, the Financial Management Act of 1979. The
 19 allottee shall be responsible for ensuring that these
 20 funds, or so much thereof as may be necessary, are used
 21 solely for the purpose specified in this act, and that no
 22 obligations are incurred in excess of the sum
 23 appropriated. The allottee of the funds appropriated
 24 under section 2 of this act shall be the Governor of Yap
 25 State; PROVIDED THAT, the allottee of funds appropriated

1 under subsection 2(i) shall be the President of COM-FSM.
2 The allottee of funds appropriated under sections 3 and 4
3 of this act shall be the President of the Federated
4 States of Micronesia or his designee, PROVIDED THAT, the
5 allottee of funds appropriated under sections
6 3(a)(b)(c)(d)(e)(f)(g)(h)(i)(j)(k)(l) and (m) shall be
7 the Mayor of Lelu Town Government; the allottee of funds
8 appropriated under sections 3(n), 3(o), 3(p), 3(q), 3(r),
9 3(s), 3(t), 3(u), 3(v), 3(w), 3(x), 3(y) [~~and~~], 3(z)
10 3(aa) and 3(ab) of this act shall be the Governor of
11 Kosrae State or his designee; the allottee of funds
12 appropriated under subsections 4(1) and 4(2)(i) of this
13 act shall be the Secretary of the Department of
14 Transportation, Communications and Infrastructure or his
15 designee; the allottee of funds appropriation under
16 sections 4(1)(a), 4(1)(b), 4(1)(d), 4(3)(a) and 4(3)(f)
17 of this act shall be the Pohnpei Transportation
18 Authority; the allottee of funds appropriated under
19 section 4(3)(h) of this act shall be the Meninkeden
20 Lapalap of Madolenimw and the allottee of funds
21 appropriated under section 4(3)(i) of this act shall be
22 the Luhkenmoanlap of Kittu. The allottee of funds
23 appropriated under subsections 5(1), 5(3) and 5(6) of
24 section 5 of this act shall be the Governor of Chuuk
25 State or his designee. The allottee of funds

1 appropriated under subsection 5(2) of section 5 of this
2 act shall be the Mortlock Islands Development Authority.
3 The allottee of funds appropriated under subsection 5(4)
4 of section 5 of this act shall be the Southern Namoneas
5 Development Authority. The allottee of funds
6 appropriated under subsection 5(5) of section 5 of this
7 act shall be the Faichuk Development Authority. The
8 authority of the allottee to obligate funds appropriated
9 by this act shall lapse on September 30, 2024."

10 Section 3. This act shall become law upon approval by the
11 President of the Federated States of Micronesia or upon its
12 becoming law without such approval.
