## A BILL FOR AN ACT

To further amend Public Law No. 20-60, as amended by Public Laws Nos. 20-65, 20-75, 20-85, 20-97, 20-150, 21-69, 21-84, 21-100, 21-129, 21-163, 21-173 and 21-187 by amending section 5 thereof, to change the use of funds previously appropriated therein, to fund public projects and social programs in the state of Chuuk, and for other purposes.
