A BILL FOR AN ACT

To further amend Public Law No. 20-178, as amended by Public Laws Nos. 21-01, 21-07, 21-36, 21-53, 21-56, 21-102, 21-115, 21-137, 21-165, 21-178, 21-200, 21-218, 21-226, 21-249 and 22-27, by amending section 6 thereof, to change the allottee of funds previously appropriated therein, to fund public projects and social programs for the people of Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 6 of Public Law No. 20-178, as amended by
Public Laws Nos. 21-01, 21-36, 21-53, 21-56, 21-102, 21-137,
21-165, 21-218, 21-226 and 21-249, is hereby further amended to
read as follows:

5 "Section 6. Allotment and management of funds and lapse 6 date. All funds appropriated by this act shall be allotted, managed, administered and accounted for in 7 8 accordance with applicable laws, including, but not 9 limited to, the Financial Management Act of 1979. The 10 allottee shall be responsible for ensuring that these 11 funds, or so much thereof as may be necessary, are used 12 solely for the purpose specified in this act, and that 13 no obligations are incurred in excess of the sum The allottee of the funds appropriated 14 appropriated. 15 under section 2 of this act shall be the Governor of Yap 16 State or his designee. The allottee of funds 17 appropriated under sections 3(a) to 3(ar) of this act

shall be the Mayor of Lelu Town Government or his 1 2 designee; PROVIDED THAT the allottee of funds appropriated under subsections 3(ad) and 4(2)(q) of this 3 act shall be the President of COM-FSM; the allottee of 4 5 funds appropriated under subsection 3(al) of this act shall be the Secretary of the FSM Department of 6 Education or his designee. The allottee of funds 7 appropriated under section 4 of this act shall be the 8 9 President of the Federated States of Micronesia or his 10 designee; PROVIDED THAT the allottee of funds appropriated under subsection 4(2)(c) of this act shall 11 be the Pohnpei Transportation Authority; the allottee of 12 funds appropriated under section 4(1) and subsection 13 14 4(3)(w) of this act shall be the Vice President of the 15 Federated States of Micronesia or his designee; EXCEPT THAT the allottee of funds appropriated under subsection 16 17 4(1)(g) of this act shall be the Governor of Pohnpei or his designee; the allottee of funds appropriated under 18 subsections 4(3)(a), 4(3)(b) and 4(3)(c) of this act 19 20 shall be the Secretary of the Department of Health and 21 Social Affairs or her designee; the allottee of funds appropriated under subsections 4(3)(d), 4(3)(y) and 22 4(3)(z) of this act shall be the Secretary of the 23 24 Department of Education or his designee; the allottee of 25 funds appropriated under subsections 4(3)(ab), 4(4)(f)

1 and 4(3)(p) of this act shall be the Pohnpei 2 Transportation Authority, the funds appropriated under subsection 4(3)(g) of this act shall be the President of 3 the Federated States of Micronesia or his designee, the 4 5 allottee of funds appropriated under subsection 4(3)(x)of this act shall be the Meninkeder Lapalap of 6 7 Madolenihmw Municipal Government or his designee; the funds appropriated under subsections 4(3)(i), 4(3)(j) of 8 9 this act shall be the Secretary of the Department of 10 Transportation, Communications and Infrastructure or his designee; the allottee of funds appropriated under 11 subsection 4(3)(ae) of this act shall be the Secretary 12 of the Department of Resources and Development or his 13 14 designee. The allottee of the funds appropriated under 15 subsections 5(1) and 5(6) of this act shall be the Governor of Chuuk State or his designee; the allottee of 16 17 the funds appropriated under subsection 5(2) of this act shall be the Mortlocks Island Development Authority 18 (MIDA); the allottee of funds appropriated under 19 20 subsection 5(3) of this act shall be the Mayor of Weno 21 Municipal Government or his designee; the allottee of the funds appropriated under subsection 5(4) of this act 22 shall be the Southern Namoneas Development Authority; 23 24 the allottee of the funds appropriated under subsection 25 5(5) of this act shall be the Faichuk Development

1	Authority. The authority of the allottee to obligate
2	funds appropriated by this act shall lapse on September
3	30, 2022."
4	Section 2. This act shall become law upon approval by the
5	President of the Federated States of Micronesia or upon its
6	becoming law without such approval.
