## A BILL FOR AN ACT

To further amend Public Law No. 18-117, as amended by Public Laws Nos. 18-120, 19-04, 19-08, 19-35, 19-49, 19-59, 19-76, 19-102, 20-26, 20-117, 21-27, 21-114, 21-166, 22-13, 22-71 and 22-121, by amending sections 3 and 6 thereof, to change the use and allottee of funds previously appropriated therein, for the purpose of funding public projects and social programs for the people in the state of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

14	4(1)(b), $4(1)(d)$ , $4(3)(a)$ and $4(3)(f)$ of this act shall
15	be the Pohnpei Transportation Authority; the allottee of
16	funds appropriated under section 4(3)(h) of this act
17	shall be the Meninkeden Lapalap of Madolenimw and the
18	allottee of funds appropriated under section 4(3)(i) of
19	this act shall be the Luhkenmoanlap of Kitti. The
20	allottee of funds appropriated under subsections 5(1),
21	5(3) and 5(6) of section 5 of this act shall be the
22	Governor of Chuuk State or his designee. The allottee of
23	funds appropriated under subsection 5(2) of section 5 of
24	this act shall be the Mortlock Islands Development
25	Authority. The allottee of funds appropriated under
