PUBLIC LAW NO. 22-120

AN ACT

To further amend Public Law No. 19-60, as amended by Public Laws Nos. 19-71, 19-80, 19-103, 19-148, 19-165, 20-30, 20-128, 21-46 and 21-139, by amending section 6 thereof, to extend the lapse date of certain funds previously appropriated therein, to fund essential government functions, programs, projects and activities in each of the states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 19-60, as amended by

Public Laws Nos. 19-71, 19-80, 19-103, 20-30, 20-128, 21-46 and

3 21-139, is hereby further amended to read as follows:

"Section 6. Allotment and management of funds and 4 lapse date. All funds appropriated by this act shall 5 6 be allotted, managed, administered and accounted for 7 in accordance with applicable laws, including, but 8 not limited to, the Financial Management Act of 1979. 9 The allottee shall be responsible for ensuring that 10 these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this 11 12 act, and that no obligations are incurred in excess 13 of the sum appropriated. The allottee of the funds 14 appropriated under section 2 of this act shall be the Governor of the State of Yap or his designee. 15 16 allottee of the funds appropriated under section 3 of this act shall be the Governor of the State of Kosrae 17

1	or his designee. The allottee of the funds
2	appropriated under section 4 of this act shall be the
3	Governor of the State of Pohnpei or his designee;
4	PROVIDED THAT, the allottee of the fund appropriated
5	under subsections $4(1)(c)$, $4(3)(a)$, $4(3)(c)$ and
6	4(4)(a) shall be the Pohnpei Transportation Authority
7	(PTA). The allottee of funds appropriated under
8	subsections $4(1)(d)$, $4(1)(e)$, $4(1)(f)$, $4(1)(g)$,
9	4(1)(h), $4(1)(i)$, $4(2)$ and $4(4)(b)$ of this act shall
10	be the Secretary of Transportation, Communications
11	and Infrastructure or his designee. The allottee of
12	the funds appropriated under section 5 of this act
13	shall be the Governor of the State of Chuuk or his
14	designee. The authority of the allottee to obligate
15	funds appropriated by this act shall lapse on
16	September 30, 2024."
