AN ACT

To further amend Public Law No. 19-54, as amended by Public Laws Nos. 19-62, 19-75, 19-79, 19-99, 19-119, 20-04, 20-56, 20-82, 20-127, 21-20, 21-117, 21-169, 21-174, 21-194, 21-205, 21-233 and 22-15, by amending section 4 thereof, to change the use of funds previously appropriated therein, to fund public projects and social programs in the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 19-54, as amended by
2 Public Laws Nos. 19-62, 19-79, 19-99, 19-119, 19-129, 19-173 and
3 22-15, is hereby further amended to read as follows:
