CONGRESSIONAL BILL NO. 21-402

AN ACT

To further amend Public Law No. 21-228, as amended by Public Law No. 21-248, by amending section 5 thereof, to change the use of funds appropriated therein, to fund public projects and social programs for the people of Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Section 5 of Public Law No. 21-228, as amended by  
2 Public Law No. 21-248, is hereby further amended to read as  
3 follows:
