Dear Speaker Simina:

I am transmitting the following act, which I have signed to become Public Law No.22-187 with item veto for the reason stated in this transmittal:

Congressional Act No. 22-177 entitled: "AN ACT TO AMEND PUBLIC LAW NO. 22-180, BY AMENDING SECTIONS 2, 3 AND 5 THEREOF, TO CHANGE THE USE OF FUNDS PREVIOUSLY APPROPRIATED THEREIN, TO FUND PUBLIC PROJECTS AND SOCIAL PROGRAMS FOR THE PEOPLE OF YAP, KOSRAE AND CHUUK STATES, AND FOR OTHER PURPOSES."

Projects and social programs for Chuuk State under Public Law No. 22-180 remains unallotted and therefore funds have yet to be expended. There is an increase in Section 5(5)(k) for project titled "Food Relief/food security program". There is no adjustment made in any of the existing projects to reflect this increase. Accordingly, Section 5(5)(k) is hereby item vetoed.

Thank you and we look forward to working with your office to rectify this matter.

AN ACT
