- WHEREAS, section 104 of title 55 of the Code of the Federated 1

- adopt a resolution setting forth the total funds estimated to be
- available for appropriation from the General Fund and any special
- funds of the National Treasury of the Federated States of Micronesia
- for each fiscal year; now, therefore,

- States of Micronesia, Seventh Special Session, 2023, that the amount
- estimated to be available for the fiscal year ending September 30,
- 2023, is set at \$145,610,740 of which \$142,709,631 is from domestic 10
- revenues, and \$1,000,000 will be available from the Amended Compact 11
- sector grant and \$1,901,109 will be available from the Supplemental 12
- Education Grant; and
