A RESOLUTION

To amend the President's Declaration of State of Emergency for the State of Chuuk as a direct result of the unusual tidal surge or King Tide affecting the islands and communities in Chuuk and assistance to the state of Chuuk as needed and warranted under the state of emergency to May 31, 2022.

- 1 WHEREAS, on December 15, 2021, the President of the
- 2 Federated States of Micronesia issued a Presidential Emergency
- 3 Declaration as a result of the unusual tidal surge in the State
- 4 of Chuuk at the request of the Governor of Chuuk; and
- 5 WHEREAS, in accordance to Article X, Section 9 (c) of the
- 6 FSM Constitution, Congress has the sole authority to revoke,
- 7 amend or extend the President's Declaration of State of
- 8 Emergency; and
- 9 WHEREAS, Congress is currently convened for its Third
- 10 Regular Session and therefore has the powers under the
- 11 Constitution to revoke, amend or extend the Declaration; now,
- 12 therefore,
- 13 BE IT RESOLVED by the Twenty-Second Congress of the
- 14 Federated States of Micronesia, Third Regular Session, 2022,
- 15 that unless sooner revoked by Congress, this Emegency
- 16 Declaration is in effect until May 31, 2022; and
